DIETETIC SERVICES

REGULATIONS POLICY NO. 120

POLICY:

Dietary department will comply with appropriate Federal OBRA Regulations and any State Regulations (i.e. Title 22, California Department Health Services.)

Consultant Dietitian, Dietary Service Supervisor, and Administrator will keep aware of current standards as regulations frequently change.

When there is a conflict between standards of the regulatory agencies, the strictest standard applies.

Facilities certified by JCAHO will also remain in compliance with JCAHO standards.
